AIM

The aim of the EU-VET CARE project (www.euvetcare.eu) is to design and implement innovative vocational training on the appropriate delivery of healthcare for migrant and refugee children. The goal of the EU-VET CARE training is to increase capacity, competence and interdisciplinary cooperation, enhancing understanding and responsiveness to diversity. Having identified health/social professionals' needs as well as the gaps in specialized training in this area, the EU-VET CARE partners developed 10 educational modules which are available for free from the project's e-learning platform

TARGET GROUPS

The primary target groups of the EU-VET CARE project are professionals working with migrant/refugee children:

- Physicians
- Psychologists
- Social workers
- Cultural mediators
- Relevant aid workers, such as interpreters, volunteers, assistants
- Professional communities, the public sector and civil society organizations

EDUCATIONAL MATERIAL

The following 10 educational modules have been developed:

5 INTERDISCIPLINARY

- Legal framework & Protocol for working with children
- Interdisciplinary collaboration
- Cultural competence
- Communication issues
- Burnout/stress prevention & management for professionals

5 SPECIALIZED

- Work with interpreters & cultural mediators in the context of treatment and counseling
- Services of interpreters/cultural mediators/cultural interpreters (for Cultural mediators)
- Managing mental health issues (for Psychologists)
- Recognizing & managing trauma & PTSD (for Social workers)
- Addressing the health needs of migrant/refugee children (for Physicians)

Each module comprises a document of background information (full length materials), a presentation (synthetic version), a vignette-case study & evaluation questions. The modules are available in English, German, Greek, Italian, and Spanish languages

DELIVERY OF THE TRAINING

Training has been developed to take place in the following two ways:

- A seminar (either face-to-face or online)
- An e-learning platform (https://learning.euvetcare. eu) providing all the training materials (in an e-learning format)

GUIDANCE & RECOMMENDATIONS FOR VET PROFESSIONALS
